GENERAL TERMS OF CREDIT

I (we), the undersigned, hereby agree and bind and oblige myself (ourselves), upon approval by LEXSUCO 2010 CORPORATION (hereinafter referred to as "LEXSUCO") of the attached credit application, to the full, absolute and total respect of the following terms and conditions, to wit:

1. Any and all sums due to LEXSUCO shall be paid thereto by the undersigned, on a net basis, no later than the thirtieth (30th) day of the month following the date of issuance by LEXSUCO of invoicing ;
2. Any and all sums owed and outstanding after the thirtieth (30th) day of the month following issuance by LEXSUCO of invoicing shall bear interest at a rate of twelve percent (12%) per annum (1% per month), calculated on a monthly basis, from the said date and until full, final and complete payment thereof, which interest shall be paid by the undersigned. In addition, a fee of 50\$ will be charged for any NSF cheque and will lead to the closing of the account;
3. I (we) hereby agree that, in the event of late or non-payment to and in favour of LEXSUCO of any amounts owed and invoiced, I (we) shall pay to and in favour of LEXSUCO, in addition to such amounts and in addition to any and all interest due for payment in accordance with section 2 of these presents, an additional amount equivalent to twenty percent (20%) of all sums invoiced, outstanding and due for payment in its favour, such additional amount representing liquidated damages payable to and in favour of LEXSUCO and such additional amount being payable to and in favour of LEXSUCO whether or not the latter is obliged to undertake legal action to recover any amount invoiced and due to it;
4. Furthermore, I (we) hereby agree and bind and oblige myself (ourselves) to the full payment to and in favour of LEXSUCO of any and all Court costs, expenses and fees, including, but without limitation, judicial stamps, judicial costs, bailiff costs, costs of service and seizure and any other costs, expenses and fees of a like nature, which may be incurred or expended by LEXSUCO in order to effect recovery of any and all sums due, outstanding and due for payment in its favour;
5. I (we) hereby recognise and agree that any and all merchandise sold to the undersigned by LEXSUCO shall remain its entire and exclusive property until full, final and complete payment thereof by the undersigned;
6. Any waiver by LEXSUCO of the breach of any provision of these presents shall not operate nor be constructed as a waiver of any subsequent breach thereof. Unless otherwise agreed upon in writing by LEXSUCO, no waiver of any right whatsoever shall be binding upon LEXSUCO, nor enforceable by the undersigned;
7. I (we) hereby authorise LEXSUCO to effect any and all useful or necessary credit or solvency researches upon the undersigned or upon any officer of the undersigned and to obtain any and all financial or solvency or credit information upon the undersigned which LEXSUCO may deem necessary or advisable in order to ascertain the undersigned's credit-worthiness;
8. I (we) represent, declare and aver that I (we) have read this Agreement in its entirety and that I (we) have understood all of the terms and conditions herein contained. I (we) further represent, declare and aver that I (we) have received all necessary and pertinent explanations with regards to the nature, extent and consequences of this Agreement and all of its covenants and undertakings. I (we) hereto further agree and recognise that the terms and conditions hereof are reasonable and are in no way prejudicial nor unduly disadvantageous;
9. This Agreement shall be binding upon the heirs, executors, administrators, curators, successors, receivers, liquidators or any other legal representative of the undersigned;
10. This Agreement shall be governed by and construed in accordance with the Laws of the Province of Ontario and the Courts of such Province shall have jurisdiction to entertain any action or recourse arising in connection herewith. The parties hereby elect domicile for the purposes of this Agreement within the judicial district of Toronto, Province of Ontario, to the exclusion of any other jurisdiction;
11. I (we) have expressly requested that these presents be drafted in the English language.
